- The City Manager mentioned that EPD had been out to check our records for our 5-year review and asked about our water contractor. She said that we really need to do something if Townsend Pipeline doesn't want to service us anymore. Councilmember Greene stated that he had not heard anything, and he feels like the city has done their due diligence with Townsend Pipeline. The City Manager asked Lamar Rogers if he could prepare a bid, and that we would let Townsend Pipeline know if they wanted to submit a bid.
