Item 4:

Consideration to Approve Packet for Contractors to fill out for nay work

for City of Waleska

Mayor Mary Helen Lamb asked for a motion to approve the packet for contractors to do work with City of Waleska. A motion was made by Councilmember Cochran, seconded by Councilmember Greene, and approved

Item 5:

Five Minute Public Hearing

Hal Stringer with Habitat for Humanity spoke on an easier way to install
the meters than putting in a new line. We will set meters to water line at
corner of Hickory Nut dr. both meters with the condition that Mr. Stringer
will transfer the easement to City of Waleska. A motion was made by
Councilmember Cochran, seconded by Councilmember Green, and
approved by all members present.

Item 6: Water System Report

- Lamar Rogers reported the City of Waleska was not awarded any money for the Lead and Copper.
- Lamar passed out all new maps for council.
- Councilmember Greene reported that he had met with Stanley Townsend, and these were his requests:
 - 1. Invoices from where the City of Waleska has paid other companies to do this work.
 - 2. Jason Townsend requested a copy of the minutes from October 9th 2023.

After they receive that they will bring to the table a contract of their own not one City of Waleska wrote up.

- Councilmember Greene also stated that he had talked with Stanley Townsend about RM Moore, and the deal was RM Moore or whoever owns it was to pay \$300,000 in impact fees, according to Cherokee County regulations. This must be paid for before a building permit is issued. There has not been a closing on the property yet. The City Manager informed the council that Trey Coogle from Readventures will come to the next meeting or the first one in April.
- Councilmember Greene mentioned that in the meeting with Stanley Townsend he mentioned that the Fate Conn pump station might not work out because the families on both sides are not in favor.

Item 7: City Manager Report

- The city manager reported she had emailed Mr. Quintana that council requested a utility easement with no response.
- The City Manager reported the alcohol excise tax revenue from 7/1/2023 2/20/2024 was \$25,000.

Item 8: City Attorney's Report

- Procurement policy councilmember Brown made a motion to use the existing code and add the appendix.
- The attorney was adamant that a meeting must be held with the City of Canton, attorneys and council about sewer issues, such as 30 Puckett Creek RD.
