Item 6: Consideration to Approve Resolution for 2023 Municipal General Election

Item 7: Consideration to Approve Huey Barnes Cost of Water Line

Mayor Mary Helen Lamb asked for a motion to approve the cost for the water line on Huey Barnes Ln at \$160,000. After much discussion, Stanley Townsend reported this was way too much. Their invoice was for 2,150 ft of line and there is only approximately 500ft of line there. Stanley Townsend reported he now knew where the lines were. A motion was made by Councilmember Costales to table this project cost until we know more about this, seconded by Councilmember Lawson, and approved by all members present.

Item 8: Five Minute Public Hearing

Mr. Kandar of 1658 Land Rd approached the Mayor and Council about his meter being installed. Mayor Lamb asked Stanley Townsend about this, and he reported that it needed a bore, and this would be done this week, depending on if locates are good. The City Manager reported all locates would be good until 4/28/23.

Item 9: Water System Report

- A motion was made by Councilmember Cochran to go ahead and have meters tested at \$300 per meter for 8 meters, seconded by Councilmember Lawson, and approved by all members present.
- Lamar Rogers reported UWS will be here this week to replace 4 services and 2 weeks later to start on the rest. Stanley Townsend reported that if he was on a big project, he couldn't leave that project for a water break and come for free anymore. He reported to UWS until further notice don't call him call Turnipseed Engineers. It was determined that the city would pay him 15% of the total project to inspect. His cost will be approximately \$50,000. Attorney John Meier will write up a project contract for Townsend pipeline.
